

DISCOUNTED REGISTRATION FEE PROMOTION FOR PEWARISAN ASNB

("Campaign")

A) Terms and Conditions

- 1. This Campaign is organised by Amanah Saham Nasional Berhad (Registration No. 197901003200 (47457-V)) ("ASNB").
- 2. This Campaign shall commence from 00.00 hours (GMT +8) on 1 October 2025 until 23:59 hours (GMT + 8) 31 December 2025 ("Campaign Period"). ASNB reserves the right to vary, postpone, reschedule and/or extend the Campaign Period at its absolute discretion.
- 3. This Campaign is open to all new and existing ASNB unit holders aged eighteen (18) years old and above who are eligible to subscribe to the Hibah Amanah or Pengisytiharan Amanah services (also known as Pewarisan ASNB) ("Pewarisan ASNB"), including all employees, staff and immediate family members (spouses and children) of the employees and staff of Permodalan Nasional Berhad (Registration No. 197801001190 (38218-X)) and its group of companies ("PNB Group") and/or the following entities whichever is applicable ("Participant"):
 - i. ASNB;
 - ii. Pelaburan Hartanah Nasional Berhad (Registration No. 198801008611 (175967-W));
 - iii. PNB Merdeka Ventures Sdn Berhad (Registration No. 200001015384 (517991-A));
 - iv. PNB Research Institute Sdn Bhd (Registration No. 198501007000 (139442-U));
 - v. Jewel Digital Ventures Sdn Bhd (Registration No. 201901007717 (1317044-M));
 - vi. PNB Commercial Sdn Berhad (Registration No. 200001015419 (518026-P)); and
 - vii. Any other company and/or entity sanctioned by the Board of Directors of ASNB.
- 4. The objective of this Campaign is to encourage greater participation from the unit holders in subscribing to Pewarisan ASNB services by raising awareness about Hibah Amanah and Pengisytiharan Amanah as estate planning instruments that facilitate swift and easier claims of ASNB investments by beneficiaries after the unit holder's demise.
- 5. To be eligible for this Campaign offer, the Participant must fulfill the following requirements:
 - (i) The Participant must be a unit holder of at least one (1) of ASNB unit trust funds;
 - (ii) The Participant must maintain a minimum balance of one thousand (1,000) units in the unit trust fund account (excluding units which are under financing/collateral/Employees' Provident Fund (EPF) Members' Investment Scheme) to be eligible for registration for Pewarisan ASNB services;
 - (iii) The Participant is not a current subscriber of Pewarisan ASNB services;



- (iv) The Participant may perform online pre-registration for the application of Pewarisan ASNB services prior to or during Campaign Period; and
- (v) The Participant must submit the required Completed Documents (as defined below) for Pewarisan ASNB services (refer to "Campaign Offer and Mechanics" terms below) to any ASNB branch during the Campaign Period. For the online pre-registration process, the Participant must submit the required Completed Documents at any ASNB branch within ninety (90) days of completing the pre-registration form, and such submission must occur during the Campaign Period.
- 6. Below are examples of scenarios to illustrate how the Participant can qualify and be eligible for this Campaign offer.

Scenario 1

The Participant visits an ASNB branch during the Campaign Period and submits the Completed Documents for the Pewarisan ASNB services application. The Participant <u>will be eligible</u> for the Campaign Offer of a Ringgit Malaysia One Hundred (RM100.00) only registration fee.

Scenario 2

The Participant completes the online pre-registration for Pewarisan ASNB services on 15th September 2025. On 3rd November 2025, the Participant submits the Completed Documents at an ASNB branch. The Participant <u>will be eligible</u> for the Campaign Offer of a Ringgit Malaysia One Hundred (RM100.00) only registration fee, as the submission within Campaign Period.

Scenario 3

The Participant submits the Completed Documents at an ASNB branch on 5th January 2026. The Participant will not be eligible for the Campaign Offer of a Ringgit Malaysia One Hundred (RM100.00) only registration fee, as the submission of the Completed Documents were made after the Campaign Period. If the Participant wishes to register for Pewarisan ASNB services, the Participant will need to pay the normal registration fee of Ringgit Malaysia One Hundred and Eighty (RM180.00) only.



Scenario 4

The Participant completes the online pre-registration for Pewarisan ASNB services on 20th October 2025. In January 2026, the participant submits the Completed Documents at an ASNB branch. However, the Participant <u>will not be eligible</u> for the Campaign offer of a Ringgit Malaysia One Hundred (RM100.00) only registration fee, as the submission of the Completed Documents were made after the Campaign Period. The Participant will need to pay the normal registration fee of Ringgit Malaysia One Hundred and Eighty (RM180.00) only.

Scenario 5

The Participant completes the online pre-registration for Pewarisan ASNB services on 11th August 2025. On 25th November 2025, the Participant submits the Completed Documents at an ASNB branch. Even though the campaign period is still ongoing, the Participant <u>will not be eligible</u> for the Campaign Offer, as the submission exceeds the ninety (90) days from the completion date of pre-registration. To be eligible for the Campaign Offer, Participants must re-perform the online pre-registration and submit the Completed Documents within Campaign Period and within ninety (90) days of the completion date of pre-registration.
