A) Terms and Conditions

1. This Campaign is organised by Amanah Saham Nasional Berhad (Registration No. 197901003200 (47457-V)) (“ASNB”).
2. This Campaign shall commence at 0:00 hours (GMT + 8) on 20 October 2025. The Lucky Draw component will run from 00:00 hours (GMT + 8) on 20 October 2025 until 23:59 hours (GMT + 8) on 31 January 2026. The New Minor UH Sign Ups & Invest RM10.00 only and Investment Tier components will run from 0:00 hours (GMT + 8) on 20 October 2025 until stocks last. ASNB reserves the right to vary, postpone, re-schedule or extend the campaign period at any time at its absolute discretion.
