

UNLOCK ASM 3 Campaign (“Campaign”)

A) Updated Terms and Conditions

1. This Campaign is organised by Amanah Saham Nasional Berhad (197901003200 (47457-V)) (“ASNB”).
2. This Campaign shall commence from 11 November 2025 (00:00 GMT +8) until 31 December 2025 (23:59 GMT +8) (“Campaign Period”). ASNB, at its absolute discretion, reserves the right to vary, postpone, re-schedule or extend the Campaign Period.
3. By participating in this Campaign, the participants (“Participants”) agree to comply with and adhere to all the terms and conditions (“Terms and Conditions”) stated herein.

4. **Eligibility**

- 4.1 This Campaign is open to all new Akaun Dewasa unit holders only including employees and immediate family members (spouses and children) of Permodalan Nasional Berhad (197801001190 (38218-X)) and its group of companies (“PNB Group”) who:
 - i) Register digitally via myASNB (mobile application only) between the Campaign Period; or
 - ii) Register digitally via Touch ‘n Go eWallet (“TNGD”) from 1 December 2025 to 31 December 2025;
 - iii) successfully complete e-KYC (Kenali Pelanggan Anda secara elektronik); and
 - iv) make their **first investment in Amanah Saham Malaysia 3 (“ASM 3”)** on the **same platform** used for registration, during the Campaign Period, with the promo code **“UNLOCK.”**
- 4.2 Each new unit holder is eligible for **one (1) transaction** only for the special quota units, subject to availability.

- 4.3 **Exclusions and Disqualification**

4.3.1 The following circumstances shall not qualify for participation in the Campaign:

- (a) digital registration before the Campaign Period;
- (b) minor, joint, corporate/institutional accounts;
- (c) over the counter (OTC) registrations at ASNB Branches and kiosk registrations;
- (d) first investment on a different platform than the registration platform;
- (e) the initial investment into ASM 3 is made after the end of the Campaign Period;
- (f) use of promo code “UNLOCK” for funds other than ASM 3; and/or
- (g) cancelled/ unsuccessful/ refunded transactions.

4.3.2 ASNB may, at its sole discretion, disqualify any participant for actual/suspected fraud, gaming, abuse, or non-compliance with these Terms and Conditions.

5. **Campaign Mechanics**

5.1 How to participate:

- i) Register **digitally** via myASNB mobile application or TNGD within the Campaign Period;
- ii) Complete **eKYC** and profile information;
- iii) Select **ASM 3** and enter promo code **“UNLOCK”** at the subscription page;
- iv) Complete payment on the **same platform** as registration; and
- v) Initial investment into ASM 3 is completed within Campaign Period.

5.2 Special Quota:

- i) One-time entitlement up to RM1,000.00 only for the first ASM 3 investment, on a first-come, first-served basis, subject to units' availability.
- ii) Single use of promo code "UNLOCK" per eligible new unit holder;
- iii) Investment follows current allowable minimum investment of RM10.00 only. Maximum under Special Quota is RM1,000.00 only. Any unused portion is forfeited and cannot be carried forward or split.

5.3 If the unit under the campaign pool is fully utilised, **UNLOCK** will no longer grant Special Quota. The unit holders may proceed to invest under the **normal ASM 3 allocation**, subject to unit availability.

Re-register (because previous account has been revoked), make first investment into ASM 3 on the same platform as registration/onboarding with promo code UNLOCK.	Eligible
Sign-up before Campaign starts/ Register ASNB account through OTC registration or kiosk registration / first investment on different platform / use promo code UNLOCK when buying fund other than ASM 3 (e.g., ASB, ASM 2 Wawasan, ASN Sara 2).	Not Eligible

All standard fees/charges (if any) applicable to ASM 3 transactions and the selected channel apply and are borne by the Participants.
