MARKET REVIEW

As at end February 2026, the fund reported an annualised return of 6.49%, over a 5-year basis, outperforming its benchmark's 2.29% return.

Global markets extended their positive momentum in February, with the FTSE All-World Index rising 1.44%. Year-to-date, global markets have seen an overall positive performance of 4.51%. Asia Pacific was the best performing region in February, with the FTSE Asia Pacific Index increased by 6.93%. The highest performing country index for the month was FTSE Korea Index at 21.87%. Conversely, the worst performing country index was the FTSE Denmark Index, finishing the month down at -18.87%. Malaysia's KLCI reversed its performance this month, declining 24.27 index points to register a -1.39% loss. Within the size segments of the FTSE Bursa Malaysia EMAS Index, FTSE Bursa Malaysia Mid 70 Index remained the best performer in the FTSE Bursa Malaysia Index Series, gaining 0.19% for the month, overshadowing the poor performance of FTSE Bursa Malaysia Small Cap Index of -1.53%. The FTSE Bursa Malaysia EMAS Index declined -1.06%. The top ten constituents of the FTSE Bursa Malaysia KLCI account for 67.68% of the index, as compared to 51.51% for the FTSE Bursa Malaysia Top 100 Index and 47.96% for FTSE Bursa Malaysia EMAS Index. Industrials was the best performing sector in the FTSE Bursa Malaysia KLCI Index, registering 1.84% with Health Care being the second-best performer at 1.79%. Conversely, Consumer Staples was the worst performing sector followed by Materials, at -3.64% and -6.10% respectively. With an index weighting of 44.05% and 6 constituents, Financials is the largest industry in the FTSE Bursa Malaysia KLCI. This compares to a weight of 32.40% and 10 constituents in the FTSE Bursa Malaysia EMAS Index. Financials is also the largest industry in the FTSE Bursa Malaysia Top 100 with an index weighting of 34.80% and 10 constituents.



Based on the Fund's portfolio returns as at 28 February 2026, the Volatility Factor (VF) for this Fund is 6.1 and is classified as "Low" (source: Novagmi). "Low" includes funds with VF that are above 4.245 but not more than 7.705. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.


