

## FREQUENTLY ASKED QUESTIONS

### DISCOUNTED REGISTRATION FEE PROMOTION FOR PEWARISAN ASNB

#### (“Campaign”)

No.	Question	Answer
1	What is the purpose of the Campaign?	<p>The Campaign intends to encourage existing and new ASNB unit holders aged 18 years old and above to subscribe to Hibah Amanah &amp; Pengisytiharan Amanah (“Pewarisan ASNB”) as an estate planning instrument, allowing for faster and easier claim of ASNB investments by the beneficiaries upon unit holders’ demise.</p> <p>Eligible unit holders that submit completed documents for Pewarisan ASNB during Campaign period will enjoy a discounted registration fee.</p>
2	How much is the discounted registration fee?	During the Campaign period, eligible unit holders are entitled to the discounted registration fee for Pewarisan ASNB at RM100.00 (“Campaign offer”), from a normal rate of RM180.00.
3	How long is the Campaign period?	The Campaign will commence from 2 May 2025 until 30 June 2025.
4	What are the criteria for participating in the Campaign?	<p>To be eligible for the Campaign offer, the requirements are as follows:</p> <ol style="list-style-type: none"> <li>1. The participant must be a unit holder of at least one ASNB unit trust fund;</li> <li>2. The participant must maintain a minimum balance of 1,000 units (excluding units under financing/ collateral/ EPF scheme) in the unit trust fund that the participant plans to register under Pewarisan ASNB;</li> <li>3. The participant is not a current subscriber of Pewarisan ASNB services; and</li> <li>4. The participant must submit the completed documents to any ASNB branch during the Campaign period.</li> </ol> <p>Note: For the online pre-registration process, the document submission must be within 90 days from the completion date of pre-registration.</p>

5	What documents should I bring for Pewarisan ASNB registration?	<p>For online pre-registration process:</p> <ul style="list-style-type: none"> <li>i. Power of Attorney</li> <li>ii. Certified true copies of identification documents (donor, donee(s)/ guardian(s), and witnesses)</li> <li>iii. Offer and Acceptance Form PH1A(A) (for Hibah Amanah only)</li> </ul> <p>For direct application at ASNB branch:</p> <ul style="list-style-type: none"> <li>i. Application Form PH1A/PH1B</li> <li>ii. Power of Attorney</li> <li>iii. Certified true copies of identification documents (donor, donee(s)/ guardian(s), and witnesses)</li> <li>iv. Offer and Acceptance Form PH1A(A) (for Hibah Amanah only)</li> </ul>
6	Where can I submit the completed documents for Pewarisan ASNB's registration to be eligible for the Campaign offer?	You can submit the documents at any ASNB branch nationwide, which is a part of Campaign terms and conditions. Those that perform online pre-registration must also submit the completed documents to the ASNB branch.
7	Do I need to make an appointment at ASNB branches to submit my documents?	No appointment is required. You may walk into any ASNB branch to submit your completed documents during the branch operating hours.
8	Should I redo my pre-registration if I complete it before the Campaign period?	No, provided that the submission of documents is made within 90 days of the pre-registration completion date and within Campaign period.
9	How much is the normal registration fee if I'm not eligible for the Campaign offer?	The normal registration fee for Pewarisan ASNB is RM180.00.
10	If I complete pre-registration on 1 April 2025 and submit documents on 25 May 2025, am I eligible for the discounted fee?	Yes, you will be eligible for the Campaign offer, as the submission falls within 90 days of the pre-registration completion date.

No.	Question	Answer
<b>11</b>	If I complete online pre-registration on 25 May 2025 and submit the documents on 10 July 2025, am I eligible for the Campaign offer?	No, you will not be eligible for the discounted fee, as the document submission is beyond the Campaign period. You will be charged at a normal rate of RM180.00.
<b>12</b>	Can I still enjoy the discounted fee if I directly apply for Pewarisan ASNB's registration instead of via online pre-registration?	Yes, as long as the document submission is within Campaign period and other criteria are met.
<b>13</b>	What happens if I miss the 90 days deadline to submit the documents after online pre-registration?	You will need to re-complete the online pre-registration and submit the documents within 90 days of the pre-registration completion date. To be eligible for the Campaign offer, the document submission must also be within Campaign period.
<b>14</b>	What is the fee involved if I have already subscribed to Pewarisan ASNB and would like to include more unit trust funds into the existing contract?	For the addition of unit trust funds, a change fee of RM20.00 will be charged.
<b>15</b>	Will I be entitled to the Campaign offer if I already have Pewarisan ASNB contract?	No. For the addition of Pewarisan ASNB contracts, you will be charged RM90.00, as per existing fee structure.
<b>16</b>	If I have revoked the existing Pewarisan ASNB contract and would like to re-subscribe during Campaign period, will I be eligible to the discounted registration fee?	Yes, assuming there is no other active Pewarisan ASNB contract when the new submission is made.
