

Auto Labur Campaign (“Campaign”)

A. Terms and Conditions

1. This campaign is organised by Amanah Saham Nasional Berhad (Registration No. 197901003200 (47457-V)) (“ASNB”).
2. The objective of this Campaign is to encourage ASNB unit holders:
 - 2.1 to invest consistently by setting up the monthly automatic investment through Auto Labur service in myASNB platform (“Auto Labur”); and
 - 2.2 to increase the investment amount in their existing Auto Labur.
3. This Campaign shall commence at 00:00 hours (GMT + 8) on 9th September 2024 until 23:59 hours (GMT +8) on 31st December 2024 (“Campaign Period”).
4. ASNB reserves the right to vary, postpone, re-schedule or extend the Campaign Period at its absolute discretion.
