

## **DISCOUNTED REGISTRATION FEE PROMOTION FOR PEWARISAN ASNB ("Campaign")**

### **Terms and Conditions**

1. This Campaign is organised by Amanah Saham Nasional Berhad (Registration No. 197901003200 (47457-V)) ("ASNB").
2. This Campaign shall commence on 1<sup>st</sup> November 2024 until 31<sup>st</sup> December 2024 ("Campaign Period"). ASNB, at its absolute discretion, reserves the right to vary, postpone, re-schedule or extend the Campaign Period.
3. This Campaign is open to all new and existing ASNB unit holders aged eighteen (18) years old and above ("Participants") who are eligible to subscribe to the Hibah Amanah or Trust Declaration services also known as Pewarisan ASNB services ("Pewarisan ASNB").
4. The Campaign's objective is to encourage greater participation from unit holders in subscribing to Pewarisan ASNB services. This will be achieved by raising awareness about Hibah Amanah and Trust Declaration as estate planning instruments that facilitate faster and easier claims of ASNB investments by beneficiaries after the unit holder's demise.
5. To be eligible for the Campaign offer, participants must fulfill the following requirements: -
  - (i) The Participant must be a unit holder of at least one ASNB unit trust fund;
  - (ii) The Participant must maintain a minimum balance of one thousand (1,000) units in the unit trust fund (excluding units which are under financing/collateral/Employees' Provident Fund (EPF) Members' Investment Scheme) to be eligible for registration for Pewarisan ASNB services;
  - (iii) The Participant is not yet a subscriber of Pewarisan ASNB services;
  - (iv) The Participant must submit the required Completed Documents for the Pewarisan ASNB services (refer to "Campaign Offer and Mechanics" terms below) to any ASNB branch during the Campaign Period; and
  - (v) If the Participant performs online pre-registration for the application of Pewarisan ASNB services, they must complete the pre-registration during the Campaign Period. Additionally, the required Completed Documents must be submitted to any ASNB branch within ninety (90) days of the online pre-registration and within the Campaign Period.

### **Campaign Offer and Mechanics**

- The campaign offers eligible Participants a discounted registration fee for Pewarisan ASNB services as follows:

- Participants can complete online pre-registration for Pewarisan ASNB services before submitting the required documents at any ASNB branch or apply directly at any ASNB branch. The registration process must be completed within the campaign period.

Note: 1. The Participant is advised to book for an appointment at an ASNB branch via ASNB website at [www.asnb.com.my](http://www.asnb.com.my).

2. Submission of Completed Documents must be done during the Campaign Period from 1<sup>st</sup> November 2024 to 31<sup>st</sup> December 2024 to be eligible for the Campaign offer.

## Examples

Below are examples of scenarios illustrating how unit holders can qualify for the Campaign Offer. These scenarios should be referenced against the Eligibility criteria items.

### **Scenario 1:**

*The Participant visits an ASNB branch during the Campaign Period and submits the Completed Documents for the Pewarisan ASNB services application. The Participant will then be eligible for the Campaign Offer of a Ringgit Malaysia One Hundred (RM100.00) registration fee.*

### **Scenario 2:**

*The Participant completes the online pre-registration for Pewarisan ASNB services in October 2024. On 1st November 2024, the Participant submits the Completed Documents at an ASNB branch. The Participant will not be eligible for the Campaign offer of a Ringgit Malaysia One Hundred (RM100.00) registration fee, as the online pre-registration was done before the Campaign Period.*

*The Participant can choose one of the following options to register and be eligible for the Campaign offer:*

- (i) Re-complete the online pre-registration and submit the Completed Documents at an ASNB branch within ninety (90) days of the online pre-registration, ensuring it is within the Campaign Period; or*
- (ii) Register for Pewarisan ASNB services directly at an ASNB branch during the Campaign Period.*

### **Scenario 3:**

*The Participant submits the Completed Documents at an ASNB branch on 30th September 2024. The Participant will not be eligible for the Campaign offer of a Ringgit Malaysia One Hundred (RM100.00) registration fee, as the submission occurred before the Campaign Period. If the Participant wishes to register for Pewarisan ASNB services, he or she will need to pay the normal registration fee of Ringgit Malaysia One Hundred and Eighty (RM180.00).*

### **Scenario 4:**

*The Participant completes the online pre-registration for Pewarisan ASNB services in November 2024. In January 2025, the participant submits the Completed Documents at an ASNB branch, within ninety (90) days of the online pre-registration. However, the Participant will not be eligible for the Campaign offer of a Ringgit Malaysia One Hundred (RM100.00) registration fee, as the submission of the Completed Documents occurred after the Campaign Period. The Participant will need to pay the normal registration fee of Ringgit Malaysia One Hundred and Eighty (RM180.00).*

## Other Terms and Conditions

1. Participants, by participating in this Campaign, agree to be bound by the Terms and Conditions herein. The decision of ASNB, as the organiser, is final and no appeals and/or disputes will be entertained.
2. ASNB shall not be held liable for whatsoever loss or damages, whether directly or indirectly, howsoever arising in connection with the Campaign. ASNB shall not be liable for any default in respect of the Campaign due to any act of God, war, riot, strike, lockout, industrial action, fire,

flood, drought, storm, pandemic, system and technical failure or any event beyond the reasonable control of ASNB.

ASNB reserves the right, at any time, to alter, shorten, cancel, suspend or terminate the Campaign earlier in whole or in part, or to vary, delete or add any of these Terms and Conditions herein, by giving written notice through [www.asnb.com.my](http://www.asnb.com.my) or ASNB's social media channels.

ASNB reserves the right to disqualify/reject any Participants who do not comply with these Terms and Conditions stated herein and/or are found or suspected to be tampering with the Campaign and/or its process or the operations of the Campaign.
