

**FUND OVERVIEW**

**Investment Objective**

The Fund seeks to generate reasonable level of distribution income and capital appreciation to the Unit holders through a diversified portfolio of investments.

**MARKET REVIEW**

As at end December 2022, the fund reported an annualised return of -2.31%, over a 5-year basis, outperforming its benchmark's -2.38% return.

Global markets moved into negative trend in December, with the FTSE All-World Index falling to -3.71%. As 2022 ended, global markets registered an overall negative performance of -17.67%. For December, Europe was the best performing region, with the FTSE Europe Index up 0.2%. The highest performing country index was FTSE Turkey Index at 11.15% for the month. Conversely, the worst performing country index was the FTSE Qatar Index, finishing the month down at -10.44%. Malaysia's KLCI rose by 6.69 index points during the month, registering a positive performance of 0.45%. Within the size segments of the FTSE Bursa Malaysia EMAS Index, the FTSE Bursa Malaysia Mid 70 Index was the best performer in the FTSE Bursa Malaysia Index Series, rising 1.28% for the month, overshadowing the poor performance of the FTSE Bursa Malaysia Small Cap Index of -0.07%. The FTSE Bursa Malaysia EMAS Index eked a gain of 0.64%. The top ten constituents of the FTSE Bursa Malaysia KLCI account for 62.22% of the index, as compared to 45.56% for FTSE Bursa Malaysia EMAS Index and 19.50% for the FTSE Bursa Malaysia Small Cap Index. Health Care was the best performing sector in the FTSE Bursa Malaysia KLCI Index, registering 7.43% with Industrials being the second-best performer at 4.65%. Conversely, Information Technology was the worst performing sector followed by Consumer Discretionary, with -6.56% and -2.52% respectively. With an index weighting of 42.17% and 7 constituents, Financials is the largest industry in the FTSE Bursa Malaysia KLCI. This compares to a weight of 31.90% and 10 constituents in the FTSE Bursa Malaysia EMAS Index. Industrial Goods & Services is the largest industry in the FTSE Bursa Malaysia Small Cap with an index weighting of 23.94% and 35 constituents.

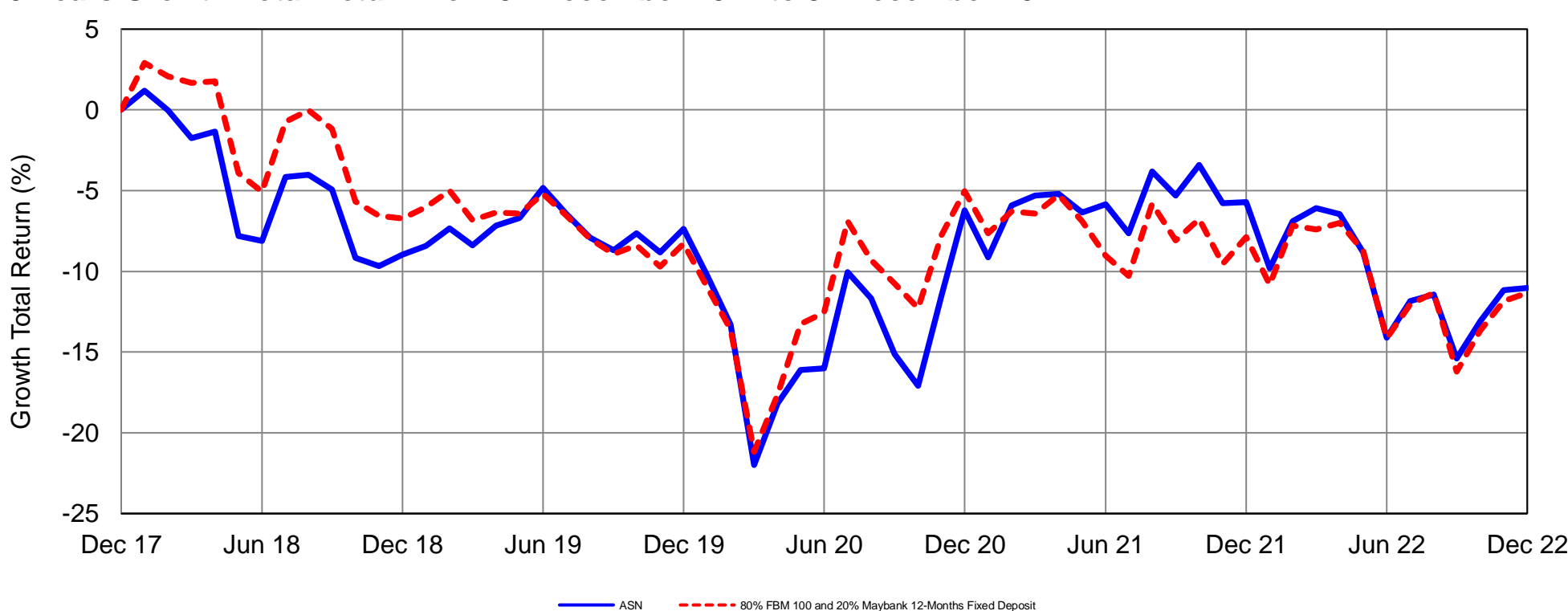

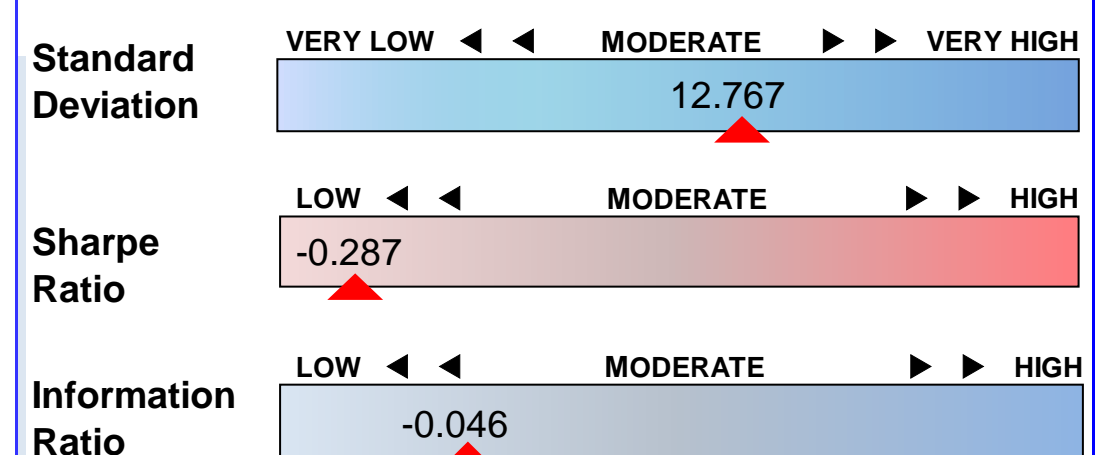

Based on the Fund's portfolio returns as at 31 December 2022, the Volatility Factor (VF) for this Fund is 12.8 and is classified as "Moderate" (source: Novagni). "Moderate" includes funds with VF that are above 11.695 but not more than 15.380. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
